He worked as a nurse in ICU so he can handle stress. He is now a profession at Madonna University. He mentors new colleagues. He was on parks and rec and is on planning commission. He was a part of two of five recreation plans. On Pc since sss. He participated in master plan and listens to residents and treats them with respect. He chaired diversity and inclusivity at Corewell. He spoke about his feelings regarding the city of Berkley including the residents.
- Andre Rogers He works for an insurance broker and manages benefits provided to employees. He would help with cost mitigation and fiscally responsible. He has not been here a year yet. He and his wife bought in April. He volunteers at Berkley schools.
- 4. Scott Rollette Lived in Berkley for 40 years. He went to Rogers, Anderson. He is a coach at Anderson. And BHS. He said he has an interesting point of view. He served as Berkley Hoops president. He had been on the board for 20+ years and president for six. Professionally he is a coach and a substitute teacher. He talked about his love and respect and passion for Berkley.
- 5. Josh Stapp Two-and-a-half-years. He said we love the small-town-feel of Berkley. He really enjoys Berkley. He is very excited at what is coming in and what is happening. He is an attorney he sits on several boards and committees. He talked about his diverse background
- 6. Stacey Stevens Thank you for the second opportunity. She discussed her professional background and her personal life. She said this time she wants to talk about her visions for Berkley. She spoke about diversity. Human Relations Commission and Youth Committee. She talked about retro feel and metro appeal. She explained how that is Berkey. She talked about her qualifications. She provided a quote by Chism, ddddfolding chair. Stronger Berkley now and into the future.

# Comments:

Dude - man from Commons explained

Mitch, Berkley resident, says he wants to make sure that the property is asdfsad. Are there any plans to make sure that space is a public space like a park.

Matt answered Mitch.

**RESOLUTION NO. R-01-23**: Matter of adopting a resolution approving a Headlee Override millage proposal for submittal to the voters on the May 2, 2023, special election ballot.

Councilmember Hennen moved to approve Resolution No. R-01-23

Seconded by Councilmember Dooley

Ayes: Baker, Dooley, Gavin, Hennen, Vilani, and Dean

Nays: None Motion Approved.

Matt opened this. He said there will be very robust dialogue with the community. Matt went through his prepared remarks. He explained it would touch everything and every single department. HE stated benefits include facilities, infrastructure, dddd. He discussed who, what, why. He said the brass tax is that we would have to cut back on external facing items if it didn't pass. He said he has been stretching tax payer dollars as much as possible. He reviewed what happened during last budget process including cutting millions of dollars. He said it is a nonsustainable track. He listed projects that were cut from the budget. He said we will be talking a lot about how we got to this point. He explained Prop A and Headlee. He said we can no longer internally cut ourselves out of it. He explained that we don't get the full amount of tax revenue. He explained how we get a fraction of that and what that does over time. He said without the general fund millage, adfas. He said we have proven in the past we are good stewards of the taxpayers' dollars. He gave examples. He said the time is here to move forward on this. He stated the last millage we weren't even able to collect that all before it was rolled back. He said it will mean staff will have to work that much harder to make use, but we are up to the task. He said our time is now before we are over a cliff or in an

emergency. He said the auditor even said the time is now. He said a homeowner can equate this to a cup of coffee a day. He said we will set up a calculator on the website so that taxpayers can exactly calculate what their tax increase will be. He said they will provide information to any group wants it. He said all information will be provided.

#### Public Comment:

Joshua Hunter, Berkley, he thinks one difference with other proposals is that there was a citizens committee. He thinks that is important. He said this is a pretty sizeable tax increase. He estimates it will be about a \$400 tax increase for the average homeowner. He said revenue is growing. He said we need to have a plan on how this money will be used and this is important because if it doesn't pass, then what? He wants residents to be informed.

Matt said we would love to have a citizens committee. He said the City can't lead this. Someone would need to step up. Matt said Mr. Hunter is correct that it would be about \$400.

Vilani – she thanked Matt for the thoughtful layout it was helpful. She said it would be helpful for residents to learn about taxable value and Zillo value.

Matt said what you can get from your home is often completely different than taxable value. He said the majority of homes the taxable value lags behind the assessed value. He explained the caps of 5 percent or dddd. Matt gave a real home example. He explained further about Headlee and millage rates. He talked about if a home is sold or new construction. He said people gets a tax break for staying in their homes. He said Headlee and Prop A is a good example where two rights make a wrong.

Hennen – thanked Matt for prepared remarks as they hit on a lot of his questions. He said there is five months which is plenty of time. He said there is a lot to share and time will go quickly.

Baker – asked Matt if it moved forward tonight what would the plans be and how would this be shared. Baker said we would rather maintain our services rather than degrade them. He thanked Matt for the opening comments.

Matt said we would be utilizing mailers, social media, taking to groups, talking to anyone, and city hall is always open for those that would like to talk about this. He reiterated he would love to see some citizen advocacy groups. He said the city has a consultant the city is working with. He said the plan is at hand.
