- Berkley is participating as a Great Michigan Read lending partner. The library has two book club kits available for this year's book, *Everything I Learned, I Learned in a Chinese Restaurant*.
- Messy Playtime continues to be a big success – 38 people attended January's snow and ice play.
- Berkley NHS and Friends President/Vice President hosted two SAT prep sessions. A total of 24 teens attended.
- The library hosted its first Arts & Crafts swap. It was a big success!

- TLN and Southfield Library will be hosting a screening of The Librarians on 2/26 at the Southfield Library.

##### A. Circulation

- Berkley resident and total circulation continues to trend up monthly.
- The Friends approved \$1,000 to establish a board and card game section in the library. It will be housed next to the puzzle section.
